3- Tender form duly filled in with prescribed earnest money in the form of **Fix Deposit Receipt or Bank Guarantee** from any of the Public Sector or Commercial bank in the sealed envelop superscripted on the top in red ink **"Limited Tender for Purchase of Dry Ration For Unit Personnel"** should reach in the office of the Commandant, 8<sup>th</sup> Bn, NDRF, Sec-19, Kamla Nehru Nagar, Ghaziabad on or before 08/08/2016 at 1400 Hrs by self drop in the tender Box or by Post on the above address.

3- Tender will be opened on the same date i.e. on 08/08/2016 at 1600 Hrs by a duly constituted board of officers in the presence of tenderers.

4- Each tender should be accompanied with **Earnest money of Rs. 55,000.00 (Rupees Fifty Five Thousand only)** in the form of **Fix Deposit Receipt or Bank Guarantee** from any of the Public Sector or commercial bank in favour of **Commandant, 8<sup>th</sup> NDRF payable at SBI, Shastri Nagar, (Code -60335) Ghaziabad (UP).** . Tender received without earnest money shall not be entertained. Earnest money of unsuccessful tenderers will be released within 01 month after finalization of contract. No interest will be paid on earnest money. EMD of successful tenderer can be converted into security deposit as performance security on their request.

5- Successful tenderer (S) will have to furnish security deposit equal to 10% of the cost of store to be specified in the form of **Fix Deposit Receipt or Bank Guarantee** from any of the Public Sector or Commercial bank which will be returned / refunded to the firm after delivery of full consignment and completion of all contractual obligations by concerned firm. The validity of such security money must be 60 days beyond the completion of the contractual obligations including warranty obligations.
