The advance sample will be tested through any Govt. Approved Laboratory capable in testing all parameters of tender enquiry specifications.</p>



<p>11.2 The Lab test report submitted by the tenderer should be free from any ambiguity and should give clear verdict in respect of all the tests required as per relevant specification i.e. whether the sample is meeting the requirement of the governing specifications and the sample is acceptable / not acceptable with reference to its governing specification. 
