1. Sealed Tenders along with product details are to be deposited in the Tender Box placed in the office of the Commandant. 12th Bn NDRF, Doimukh Post: Doimukh Dist. Papumpare Arunachal Pradesh pin - 791112, or to be sent by registered post/speed post/courier on or before **17/08/2017 at 1600 Hrs.**
2. Envelops should be super scribed with the Tender No. and Date.
3. Tenders will be opened in the presence of the bidders on **18/08/2017 at 1000 hrs** by a duly approved Board of Officers.
4. Improper or incomplete Tenders or Tender without specifications will be rejected.
5. All tenders are to be accompanied with a Demand Draft/Banker Cheque/ Deposit of Call of 3% of their quoted rate as earnest money only to be drawn in favour of the **Commandant 12th Bn NDRF, payable at SBI, Doimukh, (code No: 6892)**. This is to be retained as Earnest Money from the approved bidders.
6. Bank Drafts of unsuccessful bidders will be returned after the completion of the bidding process.
7. Bidders are to produce detailed product specification of the items, rate for which has been quoted. Price offered should be inclusive of all packing and freight charges.
8. All tenders without detailed product specification will be rejected.


