05. Tender will be opened by a duly constituted Board of Officers on 21<sup>th</sup> Sept'2017 at 1200 Hrs in the office of Commandant 2 BN NDRF, Haringhata Camp, Po-Mohanpur, Dist-Nadia, West Bengal, Pin-741246. Representative of the firms are at liberty to be present at the time of opening of tender. Tender samples are not required but brand name must be mentioned in Technical/Price bid (Only superior/reputed brand will be accepted). Tenderer are requested to submit tender documents along with catalogue or CD of the stores showing specification and technical details.

06. Tenderer are required to submit Earnest Money Deposited of Rs. 25,000/- (Rupees Twenty Five Thousand) only for TYRES, TUBES & FLAPS in the shape of Bank Draft/Bankers'Cheque drawn in favour of Commandant, 2 BN NDRF, payable at STATE BANK OF INDIA, JAGULI, Dist-Nadia along with the tender Documents.

07. The successful tenderer should deposit Security Money @ 10% of value of supply order within 15 days of being informed and execute an agreement before placing supply order on hearing from this HQ.

08. The tenderer should supply the stores at HQ 2 BN NDRF, Haringhata Camp, Po-Mohanpur, Dist-Nadia, West Bengal-741246 within stipulated period as mentioned in the supply order as per requirement of the tender. The tenderer should supply JK Tyre CO./MRF Tyre Co. TYRES, TUBES & FLAPS as per tender requirement and in case firm fails to supply the stores within delivery period, the Earnest Deposit/Security Money as deposited by the firm shall be forfeited and deposited into Government Treasury.

09. Stores will be supplied on credit basis. Bill will be accepted against delivery of stores. Payment will be released through online payment by Commandant 2 BN NDRF on proper receipt.

10. Delivery of stores are required to be affected within 90 days after placement of confirm supply order.

11. Tenderer not fulfilling any of the above terms & conditions shall be summarily rejected and no representation will be accepted.

12. **Details of manufactures** – Only those firms should respond who are manufacturers or authorized distributors of the stores specified in tender specifications. Offer from firms whose business activities are limited to procuring items from the manufacturers and supplying the same to purchaser having after sales service back up will also be entertained provided they furnish a certificate from the manufacturer certifying the authenticity, alongwith their tender, failing which their tender will be summarily rejected. Tenderer should disclose the name of full address (alongwith Telephone/Fax No.) of the place where the stores will be manufactured and offered for inspection, if any. In case the firm is registered with NSIC for the subject stores, they should clarify whether they are registered as a manufacturing unit or in any other capacity. In case the registration is as a manufacturer, they should indicate the full address and phone numbers of their manufacturing facility.

15. The Commandant 2 BN NDRF, reserves the right to reject or accept any Tender (s)/Stores without assigning any reasons. The stores supplied by the firm are subject to acceptance after survey by a Board of Officers. In case of rejection of stores, the firm will be responsible to lift the stores and to provide its replacement within a specified time at their own risk and cost.

16. The Court of Kolkata shall alone have jurisdiction to decide any dispute arising out of or in respect of the tender/contract
